GASC Behavior Agreement

GASC is a safe, caring organization where individual differences are valued, students are supported in developing leadership skills, and everyone can have fun. Because creating such an organization requires the commitment of all participants, we ask everyone to agree to the behavior expectations listed below. Students and Advisors should review and discuss these guidelines together.

I Will Show Respect For Others & Myself

- All of my actions and language will have a positive impact on others.
- I will take care of myself by getting plenty of sleep, by eating well, and by maintaining my personal health.
- I will make the most of learning opportunities at GASC by participating fully in all activities, and I will try new things and have a positive attitude.

GASC Advisor Agreement

- **I will attend each part of the program at the designated time and place and remain at the convention site for the duration of the convention.**
- I will not allow exclusive relationships (like those with friends from home or school) to prevent me from getting to know other people at GASC, or from including others in activities.
- **I will not use my cell phone during general sessions or workshops, unless instructed to do so.**
- I will be dressed appropriately at all times. School Dress Code applies to all delegates. If appearing on stage, GASC stage guidelines applies.

I Will Show Respect For The Environment & Safety

- I will pick up litter and not damage or remove anything from the environment.
- I will take care of GASC & Rock Eagle facilities, program supplies, and equipment.
- I will stay in a safe and supervised environment. **The Rock Eagle Effigy and lake are strictly prohibited.**
- I understand that the possession and use of tobacco, alcohol, or illegal drugs is prohibited.
- I understand that fireworks, firearms, pocket knives, and other weapons are not allowed.
- **I understand that ALL delegates must be in their cabins from lights out until activities begin the following morning, unless under the direct supervision of an Advisor or GASC staff member. I will stay in my living unit/sleeping area at night.**

If a delegate does not follow the behavior expectations:

- GASC Adult Executive Board will review the behavior and issue a consequence
 - Consequences will range from a warning to a permanent ban of the individual or school from all GASC events.
 - If a delegate is dismissed from a GASC event, their registration is forfeited, and their parent/guardian is responsible for picking them up immediately.
